Dear Parent/Carer

Recent Government guidance states that from 15th June schools may be able to extend their current opening arrangements, the guidance states that where possible and safe to do so schools should begin to implement contact with students sitting exams in the 2021 summer series. This means that as a school we are looking at putting plans in place for Year 10's to return to school as part of a phased/partial return.

We have been working on this return since the announcement and wanted to make you aware of the current situation.

What we know;

- At this time there has been no change to the current guidance.
- The 15th June is not a fixed date for students to return - Netherhall will only consider a return when we believe it is safe for students, parents and teachers to do so.
- Children and young people (0 to 18 years of age) who are [classed as clinically extremely vulnerable due to pre-existing medical conditions](#) are still being advised to shield. We do not expect these children to be attending school.
- Clinically vulnerable (but not clinically extremely vulnerable) people are those considered to be at a higher risk of severe illness from coronavirus. A small minority of children will fall into this category, and parents should follow medical advice if their child is in this category.
- If a child, young person or a member of staff lives with someone who is clinically vulnerable (but not clinically extremely vulnerable), including those who are pregnant, they can attend their education or childcare setting.
- If a child, young person or staff member lives in a household with someone who is extremely clinically vulnerable, as set out in the [COVID-19: guidance on shielding and protecting people defined on medical grounds as extremely vulnerable guidance](#), it is advised they only attend an education or childcare setting if stringent social distancing can be adhered to and, in the case of children, they are able to understand and follow those instructions. This may not be possible for very young children and older children without the capacity to adhere to the instructions on social distancing. If stringent social distancing cannot be adhered to, we do not expect those individuals to attend.
- It is unlikely, if not impossible to guarantee that social distancing will be adhered to 100% of the time but where possible we will endeavor to maintain the 2m guidance.
- The Government has said no fines will be issued during this time for children not attending school.

What a return would look like for your child;

- Student must arrive at the school reception at their allotted time
- All students will adhere to 2m Social distancing guidance at all times
- All pupils will be based in one classroom with a maximum class size of 15.
- Pupils will not be allowed to socialise outside of their allotted class.
- Pupils will regularly have to wash their hands.

- Pupils will have restricted access to outside areas in order to reduce social contact.
- Pupils in receipt of free school meals will receive a packed lunch, all other pupils can purchase or bring their own packed lunch. All lunches will be eaten in their classroom where the pupil is in receipt of free school meals.
- Students to be allocated a class room on their entry to school which they will remain in for the duration of the day
- Students must follow the one-way system without fail
- Student will be allocated equipment - Day 1 - Students must retain this equipment to use for the duration of the phased return
- Student are not permitted to share equipment
- Students must leave school ground when directed

What a return would look like for you;

- In order to reduce the numbers of parent and students on the site at any one point;
 - The start and finish times to the day would be staggered.
 - There would be no entry to the school building at any point
 - Drop off and pick up would be managed in a “Supermarket” style queuing system
- In order to reduce the spread of the virus;
 - Social distancing would have to be adhered to at all times.

What school will put in place;

- Will ensure that social distancing is applied where possible
- Will ensure that regular cleaning and sanitizing is taking place
- Will monitor the health of all staff and students

In order to continue with our planning for a possible return to school for your child's year group, we would be grateful if you could answer the question on the link below to let us know your intentions on whether your child will be returning to school on 15th June 2020.
